WHEREAS, samples of some person(s) belonging to Mathabhanga Municipality of Cooch Behar District have been found Positive for COVID-19; AND

WHEREAS, various restrictions and containment measures have been prescribed by extant Government Orders/ Policies/ Practices to prevent the spread of COVID-19; AND

WHEREAS, the Municipality Level COVID Task Force, Mathabhanga has unanimously requested for broad-based containment in Mathabhanga Municipality;

NOW, **THEREFORE**, I, Pawan Kadyan, IAS, District Magistrate, Cooch Behar being authorised under Section 34 read with Section 26 of the Disaster Management Act, 2005 hereby notify the following areas of Mathabhanga Municipality as a Broad-Based Containment Zone:

1	Ward No. 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12	From Part No. 250 to Part No. 270 under 2, Mathabhanga Assembly Constituency	All surrounding areas except areas notified herein are not under containment/ lockdown

In the Broad-Based Containment Zone, all Government and Private Offices, Commercial Establishments, Local Markets, Public and Private Transport and all activities shall remain closed and movement of people shall remain restricted if not covered under exceptions as below:

- 1. Health Services including movement of health personnel/ patients by public and private transport.
- 2. Administrative Offices, Municipal Offices, Law & Order, Courts, Correctional Services, Fire & Emergency Services and Fuel Refilling Centres.
- 3. Electricity, Water and Conservancy Services.
- 4. Medicine Shops and Pharmacies.
- 5. Banking and Post Office Services.
- 6. Goods & Cargo Transportation.
- 7. Continuous Process Industries and Industries with In-House Workers, Factories and Construction Work with on-site labour involving no travel.
- 8. E-Commerce, Capital and Debt Market Services as notified by SEBI.
- 9. Print Media, Electronic Media and Social Media.
- 10. PDS Ration Shop, Home Delivery Services.

Further, norms of physical distancing, wearing of masks, health and hygiene protocol must be strictly adhered to at all times. There shall be strict perimeter control for regulation of ingress/egress into/from the Containment Zone except for medical emergencies and for maintaining supply of essentials goods and services.

Shri Subrata Chakraborty, WBCS (Exe.), Deputy Magistrate & Deputy Collector, Mathabhanga is hereby appointed as Incident Commander for the abovementioned Containment Zone. He shall form Multidisciplinary Teams for effective implementation of all measures with the assistance of all concerned Govt. Agencies and Departments including Health Department, Police, Civil Defence Volunteers, etc. as deemed fit. The concerned Teams shall intensively conduct and swiftly complete the House-to-House ILI and SARI Surveillance during the lockdown, undertake Contract Tracing and other clinical interventions, as required, in the Containment Zone. The Teams shall also ensure home delivery of essential commodities in the Containment Zone as far as practicable.

This Order is issued with effect from 28th July 2020 up to 3rd August 2020.
